

**MAXIMUM RATES FOR PROVIDING PORT AND COMMERCIAL SERVICES
IN THE PUBLIC CONTAINER TERMINAL OF THE PRAT WHARF OF THE
PORT OF BARCELONA*.**

1.- PORT SERVICES:

Port services for loading/unloading, stowage/unloading and transshipment of goods (rate in euros/container)

These rates for port services are governed to all intents and purposes by the provisions of Articles 108 and following of the Law on State Ports and the Merchant Marine, recast text approved by Royal Legislative Decree 2/2011 of 5 September 2011.

II. COMMERCIAL SERVICES

Horizontal transport service (rate in euros/container)

This service includes entry at the port, reception of the container from the lorry, horizontal transport to the storage area and positioning in the storage area, or vice versa.

• Full containers that are abandoned: will be charged for import and export containers at the rate of 1.00 euro/TEU per day from the first of those two dates:		

- The date of delivery to the terminal, by the legitimate company (owner of the goods, consignee, terminal), of the request to Customs for the declaration of abandonment, provided that the declaration of abandonment is finally approved by Customs.
- Notification to the terminal of the decision adopted by Customs authorising the destruction or sale of the goods.

Accordingly, if a container is not finally declared abandoned or if during the administrative procedure regarding the abandonment of the goods, it is dispatched to the consumer, the standard rate will be applied, from the date the container enters the terminal. Similarly, when a container is declared abandoned, billing will be adjusted from the first of the dates indicated above.

Other maximum rates to be charged at the terminal

Flat rate

- Rates for the container inspection service, and stuffing and stripping containers, including stowage or removal from sheds, or rearranging cargo inside the container (for customs review or clearance or at the request of the insurance company).
 - Opening the container for inspection and subsequent closure, without needing to empty out all or part of the goods. This rate applies to both non-palletised goods and palletised goods. Rate in euros/container €30.67/container
 - Opening the container for inspection and subsequent closure, with stripping and stuffing of the container. This rate applies to both non-palletised goods and palletised goods. This rate is calculated as the sum of the following items:
 - Fixed rate (rate in euros/container) €227.32/container
 - Variable rate: rate in euros/time spent on operations (measured as the time spent on stripping and subsequent stuffing, provided that, in total, they exceed 15 minutes, in periods of an hour or part thereof). Therefore, if the total time spent on emptying and subsequent filling does not exceed 15 minutes, this variable rate will not apply. The time spent on the operation shall be calculated by adding together the time spent by all the people involved in emptying and filling the container. €23.39/hour for periods of an hour or part thereof spent working on this operation.

In the event of delays of more than 3 days between submitting an inspection request to the terminal and positioning to commence the inspection, for reasons attributable to the terminal's operations, a 10% surcharge will be added to these maximum rates.

The value of the set of rates for the container inspection service and for filling and emptying containers, shall be multiplied by the following coefficients, in 2025 and 2026 only, in order to reduce their amount:

- 2025: 75%
- 2026: 85%

Note: These rates for the container inspection service, and filling and emptying containers, do not include horizontal transport to the inspection area. However, they do include any other services associated with the inspection, such as assistance with clearance, applying new seals, or the need for temporary storage of the goods in the warehouse.

- ISPS-ADT for the implementation of measures for the protection of installations and for customs, and for the provision of services such as temporary warehouse storage (ADT) and other customs procedures not covered by other rates. This rate will be applied only to full containers being imported or exported. Rate in euros/container** 12.00

Notes:

* These commercial rates are the maximum rates applicable during any working hours, including public

holidays and nights.

*** When determining its prices, the terminal shall take into account the services actually provided, such as temporary warehouse storage (ADT) and other customs procedures not covered by other rates.*
